In pursuance to Service Selection Board and Administrative Department letters referred above, sanction is hereby accorded to the temporary appointment of Mr. Akshay Kumar son Shri Parshotam Lal resident of Marihang, Akhnoor, Jammu (ALC) as "Assistant Extension Officer" in the pay scale of Rs. 35400-112400 (Level-6) against available post in the District Industries Centre, Jammu under new Pension Scheme.

The appointee shall report to the office within a period of 21 days from the date of issuance of this order. In case, he fails to join within the stipulated period, his appointment shall be deemed to have been cancelled without any further notice.

The appointee shall be allowed to join only on the production of the following Certificates in original:

1. Academic qualification certificate/Technical qualification certificate.
2. State Subject Certificate (PRC).
3. Date of Birth / Matriculation Certificate.
4. No loan certificate under Self employment scheme from DIC concerned and Employment Department.
5. Age & Health /Medical fitness certificate from the concerned CMO of the District.
6. Relevant Category Certificate (in case candidate belong to any reserved category).

The appointee shall be initially on probation for a period of two years. If, on verification, the certificates produced by the appointee prove to be fake or forged, the appointment shall stand cancelled ab-initio.

The appointment shall further be subject to the production of an undertaking by the appointee on an affidavit to the effect that in case any adverse report about his character and antecedents is received from the office of the Additional Director General of Police, CID, J&K to whom a reference shall be made by this office, he shall have no right to claim his appointment as Assistant Extension Officer in the Department and her appointment as such shall be deemed to have been cancelled ab-initio;

The verification / genuineness of the qualification, reserved category Certificate (wherever applicable) and recognition of the Institute from the concerned issuing authorities.



The salary of the appointee shall not be drawn and disbursed to his unless a satisfactory report about the verification of his character and antecedents is received from the office of the Additional Director General of Police, CID, J&K to whom a reference shall be made by this office

This appointment shall be subject to outcome of the writ petition (s) if any, pending before any competent Court of law.
