Subject: Cancellation of appointment of "Knitting Instructor" in the Industries & Commerce Department, Directorate of Industries & Commerce Division Cadre, Jammu.

WHEREAS, on recommendations of the J&K Service Selection Board vide letter No: SSB/Sec/Sel/2017/2930-36 dated: 13.03.2017 received through Administrative Department vide letter No: IND/DIC-11/2012-I dated: 30.03.2017, Mr. Rahul Sharma son of Shri Ashok Kumar Sharma resident of Ward No:1, Mirpuram, Kathua has been appointed as Knitting Instructor vide this office Order No: 02- DI&CJ of 2018 dated; 02.01.2018;

AND WHEREAS, among other conditions, as per this office Order No: 02- DI&CJ of 2018 dated; 02.01.2018 inter alia provided that the appointee shall report to the General Manager, District Industries Centre, Rajouri within a period of 21 days from the date of issuance of the order;

AND WHEREAS, Mr. Rahul Sharma son of Shri Ashok Kumar Sharma resident of Ward No:1, Mirpuram, Kathua has been appointed as Knitting Instructor vide this office Order No: 02- DI&CJ of 2018 dated; 02.01.2018 has failed to join within the stipulated time period in the office of General Manager, District Industries Centre, Rajouri;

AND WHEREAS, a notice was served upon the appointee on Saturday August 13, 2018, to explain within seven (07) days as to why his appointment, in the Industries & Commerce Department, Directorate of Industries & Commerce Division Cadre, Jammu shall not be cancelled;

AND WHEREAS, in response to the said notice, Shri Rahul Sharma has submitted that he has filed a writ petition for reservation of one post of knitting Instructor in Hon'ble High Court vide no: SWP No.326 of 2018.

AND WHEREAS, this office after examining the writ petition No. SWP/ 326/2018, has observed that it has not been admitted in the Hon'ble High Court till date. The appointment order issued by this office vide Order No: 02- DI&CJ of 2018 dated; 02.01.2018 in favour of Mr. Rahul Sharma stipulates him to join within a period of 21 days from the date of issuance of the said order. But even after eight months, he has not joined this office.

NOW THEREFORE, it is hereby ordered that the appointment of Mr. Rahul Sharma son of Shri Ashok Kumar Sharma resident of Ward No:1, Mirpuram, Kathua in the Industries & Commerce Department, as Knitting Instructor, in the office of General Manager, DIC, Rajouri vide this office Order No: 02- DI&CJ of 2018 dated; 02.01.2018, is hereby cancelled ab-initio.
