In pursuance to Service Selection Board and Administrative Department letters referred above, sanction is hereby accorded o the temporary appointment of Mr. Sunil Dutt Sharma son Shri Om Parkash Sharma resident of Bal Shama, Sunderbani, Rajouri (OM) as "Incharge Work cum Production Centre" in the pay scale of Rs. 40800-129200 (Level-6F) against available post in the Work cum Production Centre, Kathua (under the control of General Manager, District Industries Centre, Kathua) under new Pension Scheme.

The appointee shall report to the office within a period of 21 days from the date of issuance of this order. In case, he fails to join within the stipulated period, his appointment shall be deemed to have been cancelled without any further notice.

The appointee shall be allowed to join only on the production of the following original Certificates:

1. Academic qualification certificate/Technical qualification certificate.
2. State Subject Certificate (PRC).
3. Date of Birth / Matriculation Certificate.
4. No loan certificate under Self employment scheme from DIC concerned and Employment Department.
5. Age & Health /Medical fitness certificate from the concerned CMO of the District.
6. Relevant Category Certificate (in case candidate belong to any reserved category).


The appointee shall be initially on probation for a period of two years. If, on verification, the certificates produced by the appointee prove to be fake or forged, the appointment shall stand cancelled ab-initio.

The appointment shall further be subject to the production of an undertaking by the appointee on an affidavit to the effect that in case any adverse report about his character and antecedents is received from the office of the Additional Director General of Police, CID, J&K to whom a reference shall be made by this office, she shall have no right to claim his appointment as Incharge work cum Production Centre in the Department and his appointment as such shall be deemed to have been cancelled ab-initio;

The verification / genuiness of the qualification, reserved category Certificate (wherever applicable) and recognition of the Institute from the concerned issuing authorities.

The salary of the appointee shall not be drawn and disbursed to his unless a satisfactory report about the verification of his character and antecedents is received from the office of the Additional Director General of Police, CID, J&K to whom a reference shall be made by this office

This appointment shall be subject to outcome of the writ petition (s) if any, pending before any competent Court of law.
