

In the interest of administration the Assistant Extension Officers [AEOs] of Directorate of Industries & Commerce, Jammu [Industries & Commerce Department] indicated in Annexure - 1 to this order are hereby accorded to the placement as Incharge Block Investigators [BIs] in their own pay and grade, for a period of six months or till the vacancies available in the Directorate of Industries & Commerce, Jammu [Industries & Commerce Department] are filled up on regular basis, on the recommendations of the DPC/ PSC, whichever is earlier [as per CSR article 85 (1) (b) & 85 (3) (i)] .

It is further ordered that the above arrangement shall be:

1. purely in the interest of administration on stop-gap basis and shall not confer any preferential right upon these officials for promotion as and when made against the vacancies of BIs, are considered under rules on regular basis;
2. without prejudice to seniority of the other members of Assistant Extension Officers and;
3. subject to the outcome of the writ petition(s), if any, pending before competent court(s) of law.


