Subject:- Simplification of the process of establishment of a Business

Reference: Administrative Council Decision No.17/3/2021 dated 13.02.2021.

Government Order No: 50 -IND of 2021 D a t e d: /0 .03.2021

Sanction is hereby accorded to simplifying the process of establishment of business enterprises in the UT of J&K as under:-

- i. There shall be no requirement of Registration/NoC from Industries and Commerce Department, as a pre-requisite for establishing an Industrial Unit. Any person who intends to start an Enterprise may voluntarily take registration under Udyam /IEM (of the MSME Ministry /Ministry of Commerce and Industry, Government of India) which shall suffice for an industrial unit to establish.
- ii. In case of Approvals/NoC's which may be required on case to case basis from various departments like, Power Connection, Water Connection, Approval of Building Plan, NoC from Fire and Emergency, Change of Land Use or Land Title Verification; two Committees shall monitor time bound issuance/or otherwise, of these NoC's/Approvals as per fixed timelines:
  - a. Industrial Estate Level Single Window Committee for NoCs (for units within Industrial Estates)

b. **District Level Single Window Committee for NoCs** (for units outside Industrial Estates)

- c. The Industrial Estate Level Single Window Committee for NoCs shall monitor issuance of the above Approvals/NoCs as per PSGA timelines. Likewise, District Level SW Committee for NoCs shall monitor issuance of these NoC's/Approvals within 15 days time period.
- iii. Further, there shall a 'Divisional Level Single Window Committee for NoCs', which shall periodically monitor the working of the above



Committees and address issues, if any, related to issuance of NoCs/Approvals. The composition of the Divisional Level Single Window Committee for NoCs is as under:

Furthermore, NoCs/Clearances under Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981, like Consent to Establish (CTE) and Consent to Operate (CTO) shall not come within the domain of this order and shall be sought separately as per the prescribed timelines.
