Sub: Grant of Central Capital Investment Incentive for Access to Credit (CCIIAC).



Pursuant to the approval granted by the State Level Committee under Industrial Development Scheme 2017 in its 1st Meeting held on 16.01.2021. Sanction is hereby accorded to the grant of Rs. 31,06,576/- (Rupees Thirty One Lacs Six Thousand Five Hundred and Seventy Six Only) as 30% CCIAC on plant & Machinery under Industrial Development Scheme 2017 in favour of M/s Neptune Plastics, SIDCO, I/C Bari Brahmana, Jammu as per the following break-up:

Sanction is however, subject to the following conditions:-

1. The disbursement shall be made through the financial institution, which has financed the unit.
2. All stipulations laid down in guidelines governing the IDS scheme 2017 shall apply.
3. The incentive will be released through digital payment and JKDFC would collect all information required by the DBT mission in respect of beneficiary industrial unit.
4. The unit holder shall execute/register legal documents (affidavit and indemnity bond) with JKDFC and also furnish any other requisite documents directly to JKDFC within a period of six months, failing which the sanction shall automatically lapse.
5. All formalities as per the IDS-Scheme and guidelines issued by DPIIT shall be completed at JKDFC level.
6. The General Manager shall ensure that the unit holder shall submit Annual Progress Report to the Ministry of Commerce & Industry, Department for Promotion of Industry and Internal Trade (DPIIT)/this Department about its working for a period of 5 years after going into production.
