Pursuant to the approval granted by the State Level Committee under Industrial Development Scheme 2017 in its 4<sup>th</sup> Meeting held on 03-12-2021, sanction is hereby accorded to the grant of Rs. 35,95,337/- ( Rupees Thirty Five Lacs Ninety Five Thousand Three Hundred Thirty Seven only) as 30% CCIIAC on plant & Machinery under Industrial Development Scheme 2017 in favour of M/s Jai Enterprises Phase-II, SIDCO I/C Bari Brahmana Jammu as per the following break-up:-

## Sanction is however, subject to the following conditions:-

- 1. The disbursement shall be made through the financial institution, which has financed the unit.
- 2. All stipulations laid down in guidelines governing the IDS 2017 scheme shall apply.
- 3. The incentive will be released through digital payment and JKDFC would collect all information required by the DBT mission in respect of beneficiary industrial unit.
- 4. The unit holder shall execute/register legal documents (affidavit and indemnity bond) with JKDFC and also furnish any other requisite documents directly to JKDFC within a period of six months, failing which the sanction shall automatically lapse.
- 5. All formalities as per the IDS 2017 Scheme and guidelines issued by DPIIT shall be completed at JKDFC level.
- 6. The General Manager shall ensure that the unit holder shall submit Annual Progress Report to the Ministry of Commerce & Industry, Department for Promotion of Industry and Internal Trade (DPIIT)/this Department about its working for a period of 5 years after going into production.
